GENERAL TERMS AND CONDITIONS

1. Earnest Money:

Earnest Money of Rs. 129/- may be accepted in the form of Demand Draft drawn on any scheduled Indian Bank which is approved by the Reserve Bank of India and drawn in favour of 'West Bengal Agro Industries Corporation Limited' payable at Kolkata.

i. Exemption from earnest money deposit:-

No exemption of Earnest Money will be entertained in this Tender.

ii. Refund of Earnest Money deposit:-

The Earnest Money of all the unsuccessful tenderers will be refunded by the Tender Inviting Authority within 30 days from the date of finalization of the tender on receipt of application from tenderers.

iii. Forfeiture of Earnest Money Deposit:-

- Earnest Money deposit is liable for forfeiture in the event of:
 - a) Withdrawal of offers while offers are under consideration during the validity period.
 - b) Non acceptance of work order.
 - c) Non execution of Agreement within the stipulated time, after receiving the work order.
- **iv.** No request for transfer of any previous deposit of earnest money or security deposit or payment of any pending bill held by the Department in respect of any previous work will be entertained.
- **V.** No claim shall lie against the Corporation in respect of erosion in the value or interest on the amount of Earnest Money Deposit or Security Deposit.

2. Preparation and Submission of Tender:

- Bidder should take into account any corrigendum published on Notice Board of this Corporation before submission of bids.
- > A standard format for quoting rates has been provided in the document. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable.
- > The Tenderer should sign and affix his/ her firm's stamp on each page of the Tender and all its Annexure as the acceptance of the offer. NO PAGE SHOULD BE REMOVED/DETACHED FROM THIS NOTICE INVITING TENDER.
- > The Proforma as per Annexure-III along with all other necessary documents duly completed in all respect and duly signed and in a sealed envelope (A4 Size) is to be submitted at the reception of the Corporation at the above address superscribing on the envelope "Rate for Repair of Sanitizing Tunnel" within stipulate time. The NIT No. should also be superscribed on envelope mentioning due date.
- > Before submitting the Tender, the Tenderer may inspect the site at their own cost.

3. Technical Packet:

- e) GST Registration Certificate, PAN

N.B.: Failure of submission of any of the above mentioned documents will render the tenderer liable to be rejected. If, any financial document found in the Technical Packet, the bidder shall be rejected.

4. Financial Packet:

- The Commercial Bid should be submitted in the format given in the documents. Bidders are requested to note that they should necessarily submit their financial bids in their company letter head as per the format provided and no other format is acceptable.
- The Financial Bid should submit in the Financial Packet only. In case, any rate or Financial Bid is submitted in the Technical Packet, the respective Bid will be rejected.
- The price quoted shall be firm and final and inclusive of all taxes or any other charges.
- The Tenderers should quote their rates inclusive of all demands in the Proforma as per Annexure-III. The Tenderer should quote their rate both in figure and words.
- No extra expenses will be borne by the corporation for Travelling and other purpose.
- The bid/rate will remain valid for 06 months from the date of issue of Work Order & the Tenderer will be bound to execute the supply work during the period of validity.
- No terms and conditions should be entered by the Tenderer along with commercial bid. Any conditional bid will not be entertained.
- Canvassing in any form is strictly prohibited and in the event any Tenderer is resorting to such practice, his Tender will be liable for rejection.
- Modification, in any form, by the Tenderer will not be permitted after the Tender is opened.
- The evaluation of the lowest bidder will be on basis of the item wise inclusive of all taxes & duties.

5. Payment of Bill:

- ♣ Payment will be made after 06 months of successful completion of work.
- No advance payment would be made in any case.
- 4 The vendor will not have any legal right to proceed against the Corporation in the event of late payment due to unforeseen reason.

6. Breach of Terms and Conditions:

In case of breach of any of the terms and conditions mentioned above, the competent authority will have the right to cancel the Contract without assigning any reason therefore and nothing will be payable by this Corporation in that event and security deposit shall also stand forfeited.

7. Subletting of Work:

The firm shall not assign or sublet Contract or any part of it to any other person or party without having first obtained permission in writing of the Executive Engineer, Project Division, WBAICL, Kolkata – 700001, which he will be at liberty to refuse if he/she thinks fit.

8. Non - Transferable:

The Tender is not transferable and under no circumstances the successful bidder shall be allowed to sub-contract with any other person/party/vendor. Only one Tender shall be submitted by one Tenderer.

9. Security Money:

As per Memorandum 201-F(Y) dt. 18/01/2021 of Finance Department of Govt. of West Bengal, 3% of the Total Work Order Value will be kept as Security Deposit. As such, the Earnest Money of the Successful (Lowest) Bidder will be kept as initial Security Deposit and the remaining amount equivalent to sum up the 3% of the Total Work Order Value, shall be deposited to this office within 07 days of receipt of the Work Order in favour of "West Bengal Agro Industries Corporation Ltd." payable at "Kolkata" in the form of Demand Draft.

The Security Deposit will be released after completion of work and expiry of warranty period.

- 10. Every bidder shall unconditionally accept the condition contained herein this tender. Affixation of the signature of the bidder on every page of the bid documents at the time of submission shall be the conclusive evidence of acceptance of the conditions stipulated. The bid of any bidder who does not accept any of these conditions shall not be considered.
- **11.** No Tender will be accepted by post or courier service. No request will be entertained for sending the Tender paper by post. In case, any Tenderer submit duplicate/several copy of the tender, the bid will be rejected.

- **12.** The Tenders received late after the scheduled for any reason whatsoever shall not be opened and shall be returned back to the concerned Tenderer or their authorized representative.
- 13. The contract can be terminated summarily by this office at any time without giving any notice and without assigning any reason, if the work of the supplier is found unsatisfactory during the period of this contract. In this connection the decision of the competent authority of WBAICL shall be final and binding on the firm.
- **14.** The Contract shall be interpreted in accordance with the laws of the Union of India & will be under the jurisdiction of court in West Bengal.
- **15.** In case any of the office addresses changes, then the address will be intimated and the service provider has to continue the service at the new address at no extra cost.

16. FORCE MAJEURE:

The Bidder awarded for the work shall not be considered in default, if delay in execution of contract occurs due to causes beyond his control such as natural calamities, civil wars, fire, strike floods, riot and acts of unsurpassed power. In the event of delay due to such causes, the Contract period will be extended for a length of time equal to the period of force majeure or at the option of Tender Inviting Authority, the order may be cancelled. Such cancellation would be without any liability whatsoever on the part of WBAICL.

17. Scope of Work:

- ✓ Repair of Sanitizing Tunnel by replacing following parts:
 - Pump (with SMPS if required): 300 GPD with Connectors
 - 0.02mm Mist Nozzle Sprayer (Brass): 06 Nos.
 - PIR Motion Sensor: 01 No.
- ✓ Cleaning of all pipes.
- ✓ Fixing the Nozzle properly with Teflon Tapes & m-seal, to prevent leakage.
- ✓ Nylon Cable Tie for properly fixing the pipes: 20-30 nos. (As required)
- ✓ And any other work to make the Sanitizing Tunnel functional.
- ✓ Warranty/Service Support shall be minimum for a period 01 year from the date of installation.
- Any fault in any of the above parts during the Warranty period, shall be replaced without any extra charges.
